## CASE NARRATIVE

With the exceptions noted as flags or footnotes, standard analytical protocols were followed in the analysis of the samples and no problems were encountered or anomalies observed. In addition all laboratory quality control samples were within established control limits, with any exceptions noted below. Each sample was analyzed to achieve the lowest possible reporting limit within the constraints of the method. In some cases, due to interference or analytes present at high concentrations, samples were diluted. For diluted samples, the reporting limits are adjusted relative to the dilution required.

Calculations are performed before rounding to avoid round-off errors in calculated results.

All holding times were met and proper preservation noted for the methods performed on these samples, unless otherwise detailed in the individual sections below.

### **RECEIPT**

The samples were received on 2/11/2020 10:25 AM; the samples arrived in good condition, properly preserved and, where required, on ice. The temperature of the cooler at receipt was 3.0° C.

### **PERFLUORINATED HYDROCARBONS (PFC)**

Samples Gadsden-Raw (280-133665-1) and Gadsden-Finished (280-133665-2) were analyzed for Perfluorinated Hydrocarbons (PFC) in accordance with SOP DV-LC-0012. The samples were prepared on 02/14/2020 and analyzed on 02/17/2020.

The samples Gadsden-Raw and Gadsden-Finished are flagged for ion ratio failure. It is in the analyst judgment that the detections are real and are reported with the appropriate flags.

The method required MS/MSD could not be performed due to insufficient sample volume, however, a LCS/LCSD pair was analyzed to demonstrate method precision and accuracy.

No additional analytical or quality issues were noted, other than those described above or in the Definitions/Glossary page.
