CASE NARRATIVE

With the exceptions noted as flags or footnotes, standard analytical protocols were followed in the analysis of the samples and no problems were encountered or anomalies observed. In addition all laboratory quality control samples were within established control limits, with any exceptions noted below. Each sample was analyzed to achieve the lowest possible reporting limit within the constraints of the method. In some cases, due to interference or analytes present at high concentrations, samples were diluted. For diluted samples, the reporting limits are adjusted relative to the dilution required.

Calculations are performed before rounding to avoid round-off errors in calculated results.

All holding times were met and proper preservation noted for the methods performed on these samples, unless otherwise detailed in the individual sections below.

RECEIPT

The samples were received on 8/31/2016 at 7:10 AM; the samples arrived in good condition, properly preserved and, where required, on ice. The temperature of the cooler at receipt was 0.6° C.

The container label for the following sample did not match the information listed on the Chain-of-Custody (COC): GADSDEN-RAW (280-87514-1). The container labels list Sample ID GWWSB-Raw, while the COC lists GADSDEN-RAW (280-87514-1). The sample was logged per the COC.

PERFLUORINATED HYDROCARBONS (PFC)

Samples GADSDEN-RAW (280-87514-1) and GADSDEN-FINISHED (280-87514-2) were analyzed for Perfluorinated Hydrocarbons (PFC) in accordance with SOP DV-LC-0012. The samples were prepared on 09/09/2016 and analyzed on 09/12/2016.

No analytical or quality issues were noted, other than those described above or in the Definitions/Glossary page.

PERFLUOROOCTANE SULFONAMIDE (FOSA)

Samples GADSDEN-RAW (280-87514-1) and GADSDEN-FINISHED (280-87514-2) were analyzed for Perfluorooctane Sulfonamide (FOSA) in accordance with SOP DV-LC-0012. The samples were prepared on 09/09/2016 and analyzed on 09/13/2016.

The samples in batch 280-341494 were inadvertently run with 13 injections between CCVs. The bracket included a method blank, LCS, and LCSD, so only 10 samples were run. The opening and closing CCVs were in control.

No additional analytical or quality issues were noted, other than those described above or in the Definitions/Glossary page.
