With the exceptions noted as flags or footnotes, standard analytical protocols were followed in the analysis of the samples and no problems were encountered or anomalies observed. In addition all laboratory quality control samples were within established control limits, with any exceptions noted below. Each sample was analyzed to achieve the lowest possible reporting limit within the constraints of the method. In some cases, due to interference or analytes present at high concentrations, samples were diluted. For diluted samples, the reporting limits are adjusted relative to the dilution required.

Calculations are performed before rounding to avoid round-off errors in calculated results.

All holding times were met and proper preservation noted for the methods performed on these samples, unless otherwise detailed in the individual sections below.

RECEIPT

The samples were received on 5/5/2020 9:20 AM; the samples arrived in good condition, properly preserved and, where required, on ice. The temperature of the cooler at receipt was 2.0° C.

PERFLUORINATED HYDROCARBONS (PFC)

Samples GADSDEN-RAW (280-136184-1) and GADSDEN-FINISHED (280-136184-2) were analyzed for Perfluorinated Hydrocarbons (PFC) in accordance with SOP DV-LC-0012. The samples were prepared on 05/06/2020 and analyzed on 05/08/2020.

Isotope Dilution Analyte (IDA) recovery is above the method recommended limit for the following samples: GADSDEN-RAW (280-136184-1), GADSDEN-FINISHED (280-136184-2), (LCS 280-493884/2-A), (LCSD 280-493884/3-A) and (MB 280-493884/1-A). Quantitation by isotope dilution generally precludes any adverse effect on data quality due to elevated IDA recoveries. Preparation batch 280-493884 and analytical batch 280-494338 PFC.

The continuing calibration verification (CCV) associated with batch 280-494338 recovered above the upper control limit (30%) for Perfluoroundecanoic acid (PFUnA) (35.5%). The samples associated with this CCV were non-detects for the affected analytes; therefore, the data have been reported. The associated samples are impacted: GADSDEN-RAW (280-136184-1) and GADSDEN-FINISHED (280-136184-2).

The method required MS/MSD could not be performed due to insufficient sample volume, however, a LCS/LCSD pair was analyzed to demonstrate method precision and accuracy.

No additional analytical or quality issues were noted, other than those described above or in the Definitions/Glossary page.
